**Judges Training** (Piedmont)

Mandatory

Minimum age 19 for judges training.

A pool of five or six certified judges is a comfortable number of judges for a team; two is the minimum. A panel of three judges is required for dual meet competition and a panel of five judges ideal. We had a record turn out last season and plan a repeat! Dive reps, please rsvp by Monday, the 26<sup>th</sup> to Debra with a head count to ensure a sufficient number of judges manuals.

**Rosters due (Piedmont)**

Mandatory for season participation. The final submission requires coordination between the coach and the Dive Rep. The RCSL Dive Registration form is the only form acceptable. Incomplete registration invalidates the competitor. *The signature of the dive rep certifies that each diver is a valid member of the pool, as per pool by-laws, and has been confirmed by their pool board.* Registration is to be submitted to Debra Kibler or Susan Christian on May 30 at 6:00pm at Piedmont.

Wednesday, July 2 @ 6:00 pm

**Early submission of city entries (Piedmont)**

This is an optional opportunity for coaches to turn in city entries. This advantage allows review and possible corrections of the entries prior to the deadline, To qualify for early submission all paperwork and fees must be submitted in their entirety and submitted to Debra Kibler or Susan Christian at Piedmont at 6:00 pm. Do not leave city entries in the dive box or in the office. Please let us know in advance if you choose to submit early.
